



#### **ELIGIBILITY**

The competition is open for all the College/University students and an institution shall be allowed to send only one team for the competition. Each Team shall comprise of two participants with One speaking For and the Other Against the Motion.

#### STRUCTURE OF DEBATE

Speaker	Теат	Role	Suggested Time
1 <sup>st</sup> Speaker	Proposition	Opens the debate with definitions, context and main arguments	3-4 minutes
1 <sup>st</sup> Speaker	Opposition	Responds to proposition, presents counter arguments	3-4 minutes
2 <sup>nd</sup> Speaker	Proposition	Rebuts opposition and extends the case with new arguments	3-4 minutes
2 <sup>nd</sup> Speaker	Opposition	Rebuts new points and strengthens their side	3-4 minutes
Rebuttal by 1 <sup>st</sup> Speaker	Proposition	Final response and summary of their case	1-2 minutes
Rebuttal by 1 <sup>st</sup> Speaker	Opposition	Final response and summary of their case	1-2 minutes



#### **JUDGMENT CRITERIA**

Participants will be evaluated **individually** based on the content, delivery, and approach of their presentation. The judges' decision will be final and not open to challenge.

#### **INSTRUCTIONS FOR PARTICIPANTS**

- The debate shall be conducted through ONLINE MODE.
- There would be a virtual draw of lots for the completion of all the rounds.
- There shall be FOUR ROUNDS: Preliminary, Quarter-Final, Semi-Final and Final.
- Participants must deliver their arguments in English and are strictly discouraged from reading out directly from paper, leading to disqualification of the participant.
- The organizing committee reserves the right to
- alter the rules at any point which shall be binding henceforth.
- Download the online platform link 15 minutes prior to the scheduled time.
- Mute microphones and turn off video until it's the turn to speak.
- Do not share screen during the event.

- enriched learning experience throughout the competition.

# CODE OF CONDUCT

- The host institute shall not be held liable for any issues resulting from technical glitches on the part of the participants.
